Government Order

 - d. He will leave Dhaka for China on 16 September, 2018 or on a nearer date and will leave China for Dhaka on 21 September, 2018 or on a nearer date;
 - e. He will not be allowed to stay abroad more than approved period;
 - f. He has to submit a report to the Ministry of Disaster Management and Relief within 15 (fifteen) days of his return in the country.
02. This order is issued with approval of the competent authority.


