  - b. They will draw their pay & allowances in local currency, no part of it shall be drawn in foreign currency.
  - c. Organizing authority will bear all the expenses of the participations.
  - d. They will leave Dhaka for Sri Lanka on 20 May, 2018 or on a nearer date and will leave Sri Lanka for Dhaka on 25 May, 2018 or on a nearer date.
  - e. They will not be allowed to stay abroad more than the approved period.
  - f. They have to submit a report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days of their return in the country.
02. This order is issued with approval of the competent authority.


