Government Order

 - d. He will leave Dhaka for Sanremo, Italy on 16 April, 2018 or on a nearer date and will leave Sanremo, Italy for Dhaka on 22 April, 2018 or on a nearer date.
 - e. He will not be allowed to stay abroad more than approved period.
 - f. He has to submit a report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days of his return in the country.
