- (a) Total period of this program and the time spent for travel and transit will be treated as on duty;
  - (b) He will draw all parts of his pay and allowances in local currency;
  - (c) BDT 35,00,000.00 (Thirty Five Lac) will be provided for the said Master Program from the "Strengthening Government through Capacity Development of the BCS Cadre Officials (Phase-II)" project being implemented under the Ministry of Public Administration, Government of Bangladesh.
  - (d) He will not be allowed to stay abroad more than the approved period;
  - (e) After completion of the course he will have to submit an Individual Action Plan (IAP) and all bill vouchers related to this study & overseas stay to the Ministry of Public Administration.
  - (f) The selected participant shall submit a quarterly study progress report in a prescribed form to the Ministry of Public Administration.
  - (g) If the selected participant failed to leave the country without prior approval for study on the approved date, this GO will be cancelled and treated as null & void. In that case alternative candidate will be considered and the previous candidate shall return all the Government money.
  - (h) He shall sign a bond in a prescribed form before his departure.
  - (i) He has to submit the tuition fee acknowledgement receipt before departure from Bangladesh.
