Government Order

With reference to the GO no: 05.00.0000.239.25.05.2018-538, dated: 12-04-2018, Ministry of Public Administration the undersigned is directed to convey the sanction (the deputation order) of the Government of the People's Republic of Bangladesh in favour of (1) Mr. Md. Faizur Rahman, Additional Secretary, Ministry of Disaster Management and Relief & (2) Ms. Shamima Haque, Additional Secretary, Ministry of Disaster Management and Relief to attend a Professional Development Program at Duke Centre for International Development (DCID), Sanford School of Public Policy, Duke University, United States of America under the project "Strengthening Government through Capacity Development of the BCS Cadre Officials (Phase-2)" being implemented by the Ministry of Public Administration for 14 days (including travel time) during 14-27 May, 2018 (or from the nearest possible date) under the following terms and conditions:

- a. While on Deputation they will be treated as on duty;
- b. The period of this visit and the time spent for travel and transit will be treated as on duty.
- c. They will draw their pay and allowances in local currency, no part of it shall be drawn in foreign currency;
- d. All the expenses will be borne from the fund of "Strengthening Government through Capacity Development of the BCS Cadre Officials (Phase-2)" project;
- e. They will not be allowed to stay abroad more than the approved period;
- f. After completion of the training the officers will have to submit a report (i.e. Individual Action Plan) to the Ministry of Public Administration.


