Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of (1) Mr. Md. - a. The period of this training programme and the time spent for travel and transit will be treated as on duty.
 - b. They will draw their pay & allowances in local currency; no part of it shall be drawn in foreign currency.
 - c. Organizing authority SAARC Disaster Management Center (IU) will bear all the expenses of the participation.
 - d. They will leave Dhaka for India on 28 January, 2019 or on a nearer date and will leave India for Dhaka on 02 February, 2019 or on a nearer date.
 - e. They will not be allowed to stay abroad more than the approved period.
 - f. They have to submit individual report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days of their return to the country.
02. This order is issued with approval of the competent authority.


