Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of Ms. Naila Ahmed, Deputy Secretary, Ministry of Disaster Management and Relief to participate in "Regional Dialogue on the Role of Climate proofing Growth and Development to Achieve the SDGs" during 04 to 06 March 2019 in Bangkok, Thailand under the following terms and conditions:

- d. She will leave Dhaka for Bangkok, Thailand on 03 March, 2019 or on a nearer date and will leave Bangkok, Thailand for Dhaka on 07 March 2019 or on a nearer date.
- e. She will not be allowed to stay abroad more than the approved period.
- f. She has to submit a report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days of her return in the country.

02. This order is issued with approval of the competent authority.


