**Government Order**

  - d. He will leave Dhaka for Manila, Philippines on 24 June, 2019 or on a nearer date and will leave Manila, Philippines for Dhaka on 27 June, 2019 or on a nearer date;
  - e. He will not be allowed to stay abroad more than the approved period;
  - f. He has to submit a report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days of his return to the country.
02. This order is issued with approval of the competent authority.


