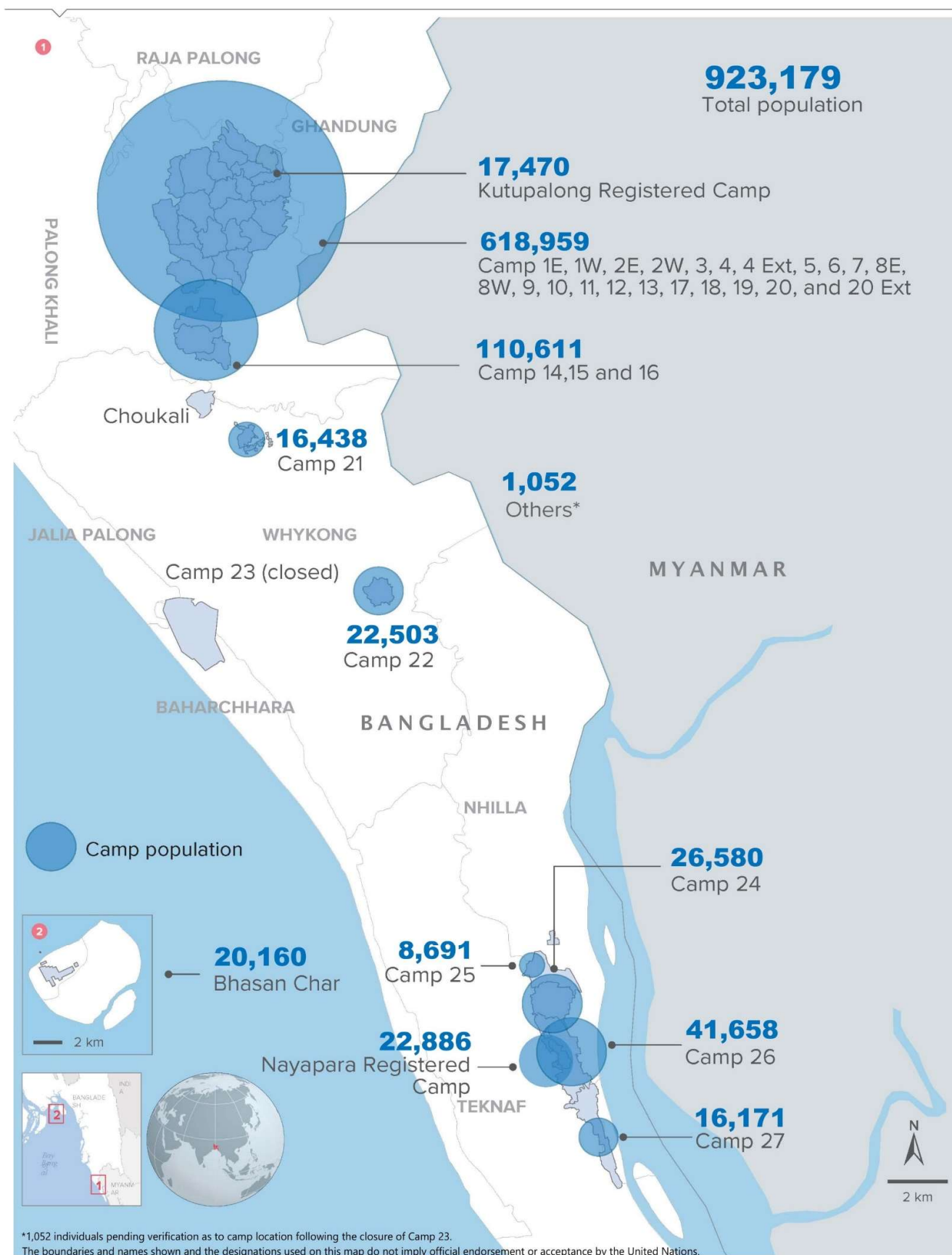

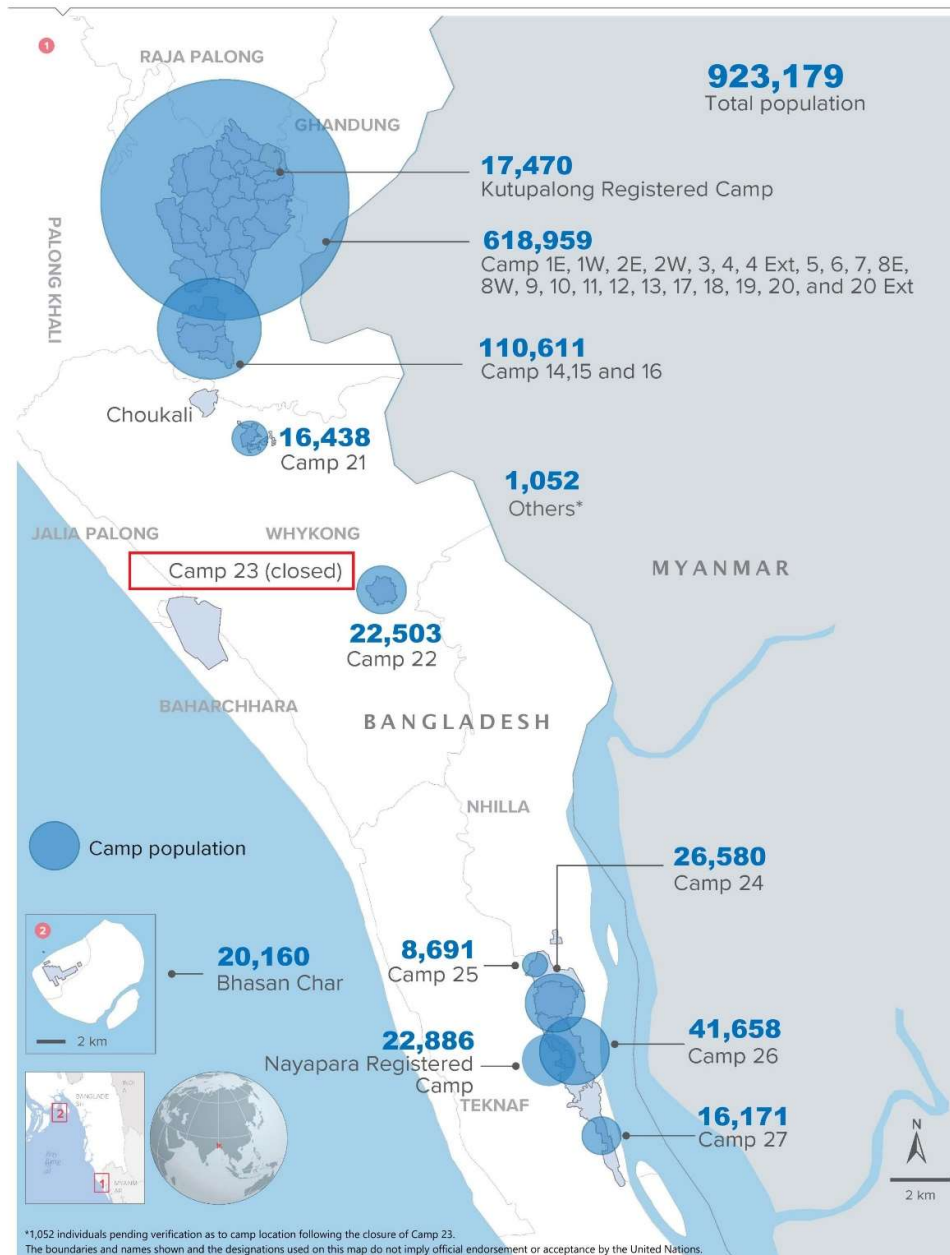

Repatriation information

A Joint Working Group was formed with the officials from different ministries of Bangladesh and Myanmar for the repatriation of Forcibly Displaced Myanmar Nationals. The committee met for the first time on 15-16 January 2018 at Nay Pyi Taw, Myanmar. Arrangements, Agreements and MoUs made and accepted at different times for the repatriations are as follows:
